**Guest Speaker:** Kelly Jessup, Community Resource Officer for the Indianapolis Metropolitan Police Department's North District. The North District extends, roughly, from 38<sup>th</sup> St to 96<sup>th</sup> St and from Michigan Rd to Shadeland Ave. It contains 220,000 residents and 79 square miles, served by 120 officers. Kelly showed us a list of the 64 police reports created in the last 90 days for the area within ¾ mile of 65<sup>th</sup> & Sherman. She noted that this is a very low number for such an area (shrinking it down to ¼ mile, which still covers most of FSNA, yields only 2 reports).

The most frequent incidents were smash-&-grabs from cars and knock-&-enter incidents in homes. The car incidents occur in parking lots, where the perps will break a window (if necessary) and quickly seize anything saleable. These should *always* be reported (323-6111) but there is little hope of recovery without serial numbers. In the house incidents, they will knock on your door. If there is no answer, they kick the door in, take what's available, and leave. If you're home, make a noise or talk through the door to get them to leave. Alarms will not stop them entering an empty house, since several minutes will necessarily elapse before police arrive. Again, *always* report (327-6111, or 911 if it's ongoing).
