#### **Guest Speaker- Burglary Prevention**

At 7:10 PM, Daphne Whitmore from the Marion County Prosecutor's office began a Powerpoint presentation on the ways to prevent your property from being a target for burglars. She passed out folders to all present with information on MOST (Multi-Jurisdictional Offender Strategy Team). This program allows the prosecutors to go beyond jurisdictional lines so that all the surrounding counties can exchange knowledge of property crimes.

She also presented ways to proactively protect your own home. Common sense ideas: maintain landscape, provide adequate light, always lock doors (dead bolts, steel doors are best), alarm systems, and KNOW YOUR NEIGHBORS. A network of watchful neighbors is the best deterrent to crime.

During her presentation, many neighbors interjected their experiences with crime. Many asked specific questions concerning right to confront intruders while armed. Also many voiced frustration with the police and their response to burglaries. Ms Whitmore answered as best as she could, but her real purpose was to present her program. The program concluded at 8:30. All present thanked her for her time and effort.

Terry Dobson then made a plea for new crime watch Block Captains. We are short of volunteers which hinders our ability to inform our neighbors of crime trends.
