President Joe Goeller called the meeting to order at 7:05 PM. Our program for the evening was on the Crime Watch Program/Operation Open Door. IMPD Community Relations Officers **Lindsey Terry and Michael Maxwell** made the presentation.

Guest Speakers

The officers began by talking about neighborhood crime trends. In August, night-time burglaries were prevalent; as of October, they seem to have stopped. Shortly before our meeting, an 18-year-old and two brothers 14 and 15 were arrested. They are presently in jail as suspects in the rash of home burglaries in our area. There were 35 cases, with them being charged in 14 cases. They lived well south of our neighborhood boundaries. The officers explained that the North District covers 80 square miles. There are 20 patrol officers assigned to our area. On any given shift, 3 officers cover the area from East 62nd Street to 96th Street, and from Keystone Avenue to Geist Reservoir.

The officers will send Joe the North District bi-monthly newsletter and will e-mail monthly crime statistics to him.
