John Strange PTO Landscaping - by Tom Sturmer

Michelle Lanosga, PTO liaison and project organizer, will speak at our May 15th Annual Meeting about this project once the election of officers has taken place. Michelle will bring drawings showing the proposed planting plan for both the school's front entrance and around the monument sign near East 62nd Street. She will also discuss opportunities to help with the plant installations once these activities have been scheduled.

The old 1960/1970's era landscaping has already been removed at the school entrance, and new planting is ready to go! We, as a neighborhood organization, could decide to focus our volunteer efforts on the area around the monument sign, while school families concentrate on the front entrance. *Please contact Michelle at 255-8714, if you are interested in helping.*

This project was funded by a \$4,985 grant from the Lowe's Toolbox for Education program, a gift of \$500 from FSNA, with more fundraising being conducted at John Strange. Once completed, a plant installation day(s) will be scheduled.

FSNA Drainage Problem Mapping Project - by Tom Sturmer

Thank you all who have provided feedback so far on this project. Approximately 40 survey responses have been returned to FSNA as of May 1st, with varying amounts of information. Some responses have just noted a drainage problem area on the map provided on the back side of the survey form. Some responses are very detailed with written narratives, drawings, and photos of the problems. All responses are valued!

We are in the process of compiling the information we have with the goal of making a preliminary presentation at the May 15th Annual Meeting. All of the problem locations will be assembled on a map, which will be coupled with a spreadsheet that provides summary information for each location. Our plan is to post this initial information on our website this summer, while continuing to solicit input.

The map and spreadsheet will be completed this Fall, with the goal of setting up meetings with agencies that can potentially help to address the problems. So far, the Department of Public Works (DPW), Citizens Energy Group, and the Marion County Soil and Water Conservation District have been identified as stakeholders. We will further work with our City-County Councilor, Christine Scales, to focus attention on our neighborhood.

Sidewalk Maintenance - by Tom Sturmer

No, this isn't an announcement about how the City is going to fix our north/south direction streets, but it <u>is</u> a reminder of how we as neighbors can maintain those that we do have. As more and more people use the sidewalks and the Trail in our neighborhood, here are a few suggestions about how property owners can do their part to promote walking along our streets.

- **1.** Remove sticks and other debris including trash from your sidewalk.
- 2. Blow cut grass off sidewalk, such as making an extra pass with your lawnmower or by using a blower.
- 3. Clear away bushes and brush which invades the sidewalk space.
- **4.** Try not to block the sidewalk with your parked vehicle.
- **5.** Dog-Walkers: Pick up your dog's waste.
- 6. Don't place garbage cans or recycling containers on sidewalk.

As a NEIGHBORHOOD ASSOCIATION, let's see what we can accomplish in addressing the major sidewalk issues with City officials and the Department of Public Works (DPW).

As NEIGHBORS, let us all do our part to make Fairfields-Sylvan a desirable place to live!

Editor's Note: Homeowners are encouraged to maintain the infrastructure of our existing sidewalks and curbs, before it becomes necessary for DPW to rebuild them. Destroy invasive plants growing from sidewalks and street gutters with weed-killer sprays, weed whackers and other tools, or even pulling out by hand.

Keep Indianapolis Beautiful, Inc. will supply neighbors who sign up to be Adopt-A-Block Coordinators with extra-width shovels for removing leaves and other debris along street curbs and storm sewers. This can further improve FSNA water drainage.
