Open Burning Can Damage Your Health by Tom Sturmer

Dear Neighbors,

With the arrival of our nice spring weather, it has been great to be able to open the windows and sit outside when not doing yard work. The air seems so fresh and clean until.....smoke starts making its way through the neighborhood. Speaking as someone who has enjoyed many a campfire, having an open fire can be a joy on the chilly evenings of spring and autumn. Unfortunately, some parts of our neighborhood end up with smoke hanging over residential property due to temperature "inversions" in the atmosphere, which ends up taking many hours to clear out.

Rules regarding open burning and bonfire/campfires were discussed at the April 16th FSNA meeting. *Jennifer Schick from the Indianapolis Office of Code Enforcement* distributed copies of the Open Burning Response Program and Bonfire and Campfire Guidelines which are now *posted on our FSNA website*. To summarize, only dried twigs, limbs, and branches originating on the residential property can be burned during the hours of 10 AM and 3:00 PM in a non-combustible container with a ventilated mesh covering. Water or other means of extinguishing fire must be present at all times, and the fire must be attended at all times. Burning of wood products causing annoyance or constituting a nuisance to health or well-being is unlawful.

Similar rules exist for campfires, except that the campfire and cookouts must be contained within a ring of bricks or stone. The Fire Department should be contacted before planning an event involving a bonfire. *Note that leaves, paper, trash, garbage are not allowed to be burned.*

Do you know that Indianapolis has a fairly significant air-quality problem? Asthma rates are high in our metro area, and small particulates (such as those caused by burning) are a leading cause of cardio-pulmonary related diseases, such as asthma, heart attacks, and lung cancer. Indianapolis ranked as the 20th most polluted city in the nation for year-round particle pollution, according to the American Lung Association's "State of the Air 2014" report.

Please do your part to keep our neighborhood healthy and enjoyable by limiting outdoor burning and always following the City's ordinances and guidelines, <u>www.municode.com</u>, Chapter 511.

FSNA to Support JSS Landscaping Project Again! - by Michelle Lanosga

I heard through Ted and Amy Hudnut that FSNA might be interested in helping sponsor another portion of John Strange's landscaping project. This is very exciting news! We appreciated greatly FSNA's donation last year, and it was key in the financing of the professional assistance that we received in the design and preparation of the beds near the school's entrance.

We are still trying to make arrangements for the second phase of our landscaping work-the area around the sign at 62nd and Olney Streets. The problem we have at that corner is irrigation. The custodians told me they have trouble with the hoses when they are stretched a long distance because the hoses lose water pressure, and the watering just isn't very efficient.

As you may recall, we are planning to plant trees, as well as perennials, on that corner, and since the plant material, especially the trees, will involve significant expenditures, I wanted to address the watering concerns BEFORE the trees and plants are ordered. Our landscape designer has given us several ideas, but I think what seems most promising is the purchase of a large water tank that can be attached to the back of the little tractor that John Strange has. I am currently investigating size, cost, availability, etc., for such a purchase.

Please let me know what information you need for FSNA to review and consider another possible donation to our project, and I will be glad to put it together. The John Strange PTO, administration, teachers, staff and families have been supportive of this project, and it is wonderful that the neighborhood is also playing such an important and supportive role!
