Despite a 90-degree day with high humidity, a hardy group of some 40 or more neighbors turned out for this FSNA neighborhood celebration. After decorating bikes, trikes, strollers, and wagons with balloons, streamers, and flags provided by Fairfields-Sylvan directors and volunteers, the crowd assembled behind our Grand Marshal, City-County Councilor Christine Scales. To the sound of siren and horns, Fire Engine 21 from the 71st Street Station led us in a loop from the south driveway through the north parking lot, returning to the John Strange School main entrance facing North Olney Street. Young families and happy children followed the Fire Engine, participating with "seasoned citizens".

After the parade, the firefighters conducted a tour of Fire Engine 21, informing children and adults about its features and equipment. A number of boys and girls climbed up into the truck and driver's cab. Afterward, many adults retreated to the shade and a breeze under main entrance canopy. Crime Watch – Operation Open Door – by Councilor Christine Scales

IMPD North District Officers Terry Lindsey and Maxwell Terry are currently visiting neighborhood associations as part of Operation Open Door, demonstrating their commitment to the neighbors they serve. They work with residents, communicating security procedures to prevent crimes and finding those responsible for unsolved crimes. These officers have circulated fliers throughout neighborhoods as to crime activity alerts, holding numerous meetings, and patrolling streets after their work shifts. They are doing all they can with existing resources. WE need to help them continue to protect the public, while keeping themselves as safe as possible in the dangerous work they do.

The City-County Council budget process is moving forward. Currently, IMPD's budget does not include funds for a new recruit class in 2013, even though it is estimated that Indianapolis is already 200 officers short at this time. The number of officers retiring in 2013 will reduce law enforcement officer ranks even further.

This is the time to contact Mayor Ballard and your City-County Councilors, including At-Large Councilors. Tell them that our neighborhoods need more than just maintaining the current level of policing in place now. Officers cannot be shuffled around between zones and districts, leaving one coverage area spread thin to respond to runs in distant corners of our District.

East 62nd Street Multi-Use Trail

After a sweltering summer, the 62nd Street Trail should be done by the end of September!

According to DPW Project Manager, Dewey Witte, construction which started in March is nearly finished. Issues of record triple-digit degree days and sewer pipe complications delayed independent contractor. Proposed trail signs will also be installed by month-end. Proposed tree planting and grass restoration may not happen until next spring due to existing drought condition. Recent rainfall could advance the planting situation to yet this fall.

Fairfields-Sylvan is considering repainting all fire hydrants along East 62nd Street to celebrate Trail completion.

- 1. Remove branches and debris from the sidewalk. I'm sure that the users of the sidewalks can also help with this.
- 2. Consider making an extra pass over the sidewalk with your mower to blow off cut grass. For those who walk their kids to school or their pets in the morning, the wet grass ends up getting tracked into our homes. Please show your neighbors that you care about them by doing this regularly.
- 3. Clear brush that is protruding into sidewalk space. In some places in the neighborhood, you must walk off of the sidewalk and into the mud to get around these obstacles. Trimming bushes and trees once in the spring and fall is usually enough to keep the pathways clear.
- 4. Try not to block the sidewalk with your parked car.
- 5. Don't let your dog defecate on the sidewalk. If he/she does, please pick it up. There is nothing worse than having your child have dog crap on their shoes all day in school.
