## Neighborhood News

## President's Report May 2012 - 2013 by Joe Goeller

In view of our full agenda for May 15, 2013, only highlights of our activities during the last years will be presented:

- 1. FSNA expanded its boundaries to include neighbors on Dearborn Street, Oakland Avenue, north side of 65<sup>th</sup> Street from Allisonville Road to Tuxedo Street, adding some 75 households to a total of nearly 500.
- 2. Tom Sturmer completed his Neighborhood Priorities Survey results, which are posted on our website.
- 3. The Annual Neighborhood Clean-up was held on Saturday, April 7, 2012, followed by a Spring Egg Hunt. Due to an early Easter and Spring Break this year, no Spring Egg Hunt was held. In 2013, the Annual Neighborhood Cleanup occurred on Saturday, April 13.
- 4. We had a spike in Crime Watch incidents last year, including home invasions. With the recently passed "Cash for Gold" state law sponsored by Rep.Christina Hale, it is hoped that we have a more peaceful summer and year.
- 5. Our 20<sup>th</sup> Independence Parade & Pitch-In outing was conducted on Saturday, June 30, on the John Strange School grounds, with Fire Engine 21 leading the parade.
- 6. In conjunction with construction of East 62<sup>nd</sup> Street Trail, Greater Allisonville volunteers, including Joie Woods and myself, painted fire hydrants along 62<sup>nd</sup> Street from Keystone Avenue to Allisonville Road on Saturday, September 22<sup>nd</sup>.
- 7. The November association meeting was cancelled as the Third Wednesday was a day before Thanksgiving. FSNA does not meet in December due to Christmas preparations.
- 8. At our first meeting of 2013 on January 16th, Councilor Christine Scales presented an extensive report on her activities for District 4 voters, answering questions from an audience of neighbors. The February 20<sup>th</sup> guest speaker was Laura Blank of Republic Recycling. We had a DPW review of Trail construction on March 20<sup>th</sup>, with Joseph Jarzen of Keep Indianapolis Beautiful Inc. speaking at our April 17<sup>th</sup> session.
- 9. On Saturday, March 16<sup>th</sup>, Mayor Greg Ballard, State Representative Christina Hale, Ted Hudnut, and I spoke during East 62<sup>nd</sup> Street Trail Dedication occurred at John Strange main entrance. Ted presented Memorial Marker honoring "JD" Smith to his wife, Connie.
- 10. Upcoming projects are Tom's Drainage-Problem Mapping Survey continuing into the Fall; Community Service Fire Hydrants painting this Saturday, May 18<sup>th</sup>. Volunteers can join at the 62<sup>nd</sup> and Dean parking lot near Tuchman Cleaners at 9:00 am; John Strange PTO Learning Landscaping being organized by Michelle Lanosga; and the 21<sup>st</sup> Independence Parade & Pitch-In for Saturday, June 29<sup>th</sup>.

# John Strange School Landscaping Project

### Major New Foundation Plants and Flowers by Main Doors and School Sign

Michelle Lanosga, PTO Liaison and project organizer, provided designs for landscaping around sign at East 62<sup>nd</sup> and Olney Streets, as well as school front entrance, having a significant impact on the beauty of entire area. She made a presentation at Fairfelds-Sylvan May 15<sup>th</sup> meeting about goals for the project, what the finished work would look like, and opportunities for volunteering. She received a \$500.00 FSNA donation and signed up neighbor volunteers to assist PTO parents and children in removing old shrubbery and installing new plants.

## **Neighborhood Improvements over the Years**

FSNA was incorporated in July 1999, at a time when East 62<sup>nd</sup> Street was in poor repair and East 61<sup>st</sup> Street crumbling as well as its sidewalks. Councilor Christine Scales had no sooner been elected for her first term, when she was visited by Fairfields-Sylvan neighbors John "JD" Smith and Dr. Robert Lehnen. "JD" was known as an avid 10-speed bicycle rider. They proposed plans for a multi-use pedestrian trail along 62<sup>nd</sup> Street connecting Binford Boulevard to Broad Ripple Park and Village.

Facing many obstacles, she persevered and frequently attended association meetings. The FSNA Board conducted a survey of neighbors finding support for a Trail, while an audio-visual slideshow in July 1999 depicted the deplorable "third world" conditions on East 61<sup>st</sup> Street. With Mayor Ballard's election, the City began moving efficiently on fixing potholes and renewing infrastructure. Suddenly and almost unbelievably, both streets were resurfaced the same year, and new sidewalks installed on East 61<sup>st</sup> Street.

Planning for an East 62<sup>nd</sup> Street Trail picked up in late 2011 as Department of Public Works held communications meetings with groups of citizens, displaying photos and graphics of proposed plans. Construction began in 2012, being slowed by torrid drought conditions during the summer but nearing completion by yearend including putting down grass seed. Trees were planted in Spring 2013, with Fairfields-Sylvan residents attending Trail Dedication ceremony on Saturday, March 16<sup>th</sup> in honor of "JD" who had died. Mayor Greg Ballard and State Rep. Christina Hale were present as guest speakers for this significant neighborhood celebration!

- 6. What you think the solution may be.
